SUBJECT: PREQUALIFICATION APPLICATION: RIO SCHOOL DISTRICT UNIFORM PUBLIC CONSTRUCTION CONTRACT PROGRAM (2024)

In June 2005, the Rio School District ("District") Board of Trustees ("Board") authorized the District's participation in the California Uniform Public Construction Contract Program. As a condition of bidding, and in accordance with the California Uniform Public Construction Cost Accounting Act (CUPCCAA), including the provisions of section 22034 of the Public Contract Code, and District Board Policy 3311, prospective contractors (bidders) on projects with an estimated cost of less than \$200,000.00 are required to complete and submit the attached pre-qualification application. (CUPCCAA Application)

CUPCCAA allows for public project work in the amount of \$60,000 or less to be performed by a public agency's force account, by negotiated contract, or by purchase order (Public Contract Code section 22032(a)). Public projects in the amount of \$200,000 or less may use the informal bidding procedures set forth in Section 22032(b) of the Public Contract Code. Public projects at a cost of more than \$200,000 shall use formal bidding procedures to let the contract pursuant to Public Contract Code Section 22032(c). These limits are effective January 1, 2019.

The District will not accept any bid from any contractor in the CUPCCAA Program that is not registered with the Department of Industrial Relations as a public works contractor.

Acceptance and approval of this application by the District ensures that the company/contractor will be notified of any work to be done under the auspices of this program for which the company/contractor is qualified; there is no guarantee, either specific or implied, of an award of any contract. Bids or quotations for projects requiring prequalification will not be accepted if a contractor's approved prequalification statement is not on file with the District.
